## Commodore's Column

It's been a quiet month at the (full) lake with nothing but beer can races going on. Lots of activities going on off the lake, however.

We held a board meeting last month to discuss several issues. One issue is still being discussed, but the other items included:

- Valley Lipton Cup – We are still waiting to hear from the other clubs involved (they haven't been responding to our emails lately). We had lots of discussion (Portsmouth vs. PHRF and boat-for-boat vs. using the ratings). Seems to be a lack of trust (just like the real thing!) from the various clubs to 'do the right thing' as far as selecting boats is concerned. We will be continuing to force the issue to get this event back on track.
- Sea Scouts (actually the Sacramento Delta Youth Maritime Association) – We discussed the ideas behind an agreement we are working out with them. The board voted to continue the discussions with them to work out the some issues before bringing it the membership.
- There was one other discussion which the board tentatively agreed with, but we going to meet again (on June 7th) to discuss it more, once everyone had a chance to really think about it.

As you can see, we are working to find ways to improve the value a FLYC membership can bring to you. And it's not too early to consider volunteering for a board position for next year so you too can help grow the club.

I just got back from a trip to Eugene, Oregon to race in the 64th annual Memorial Day regatta. They too are feeling the crunch with about 20% less boats than last year. We still had 20 Santana 20's on the start line on Saturday, where we got three light air races in. The wind was a complete no-show on Sunday (In the 10 years or so I've been going to this regatta, I think it's the first time we never even left the dock). When the results were tallied up, we ended up 3rd. Jason Crowson, another Northern California boat, won the regatta. Barb and Todd Craig (with Mark Werder as crew) also raced, but it was their first time in a large fleet in many years. That caused them to have trouble finding clear air so they ended up in the middle of the fleet.

A quick plug for Morrison Marine. I took my tired looking oxidized blue boat into Mel's shop and came back with a boat that looked almost new! That, and a new sail from Sherron Hart probably greatly contributed to the great result we had up a Eugene.

Coming up in June is combined Katheryn Eavenson/Lady and the Tramp regatta on June 19th. Also in June is Fleet 4's annual Big Brother/Big Sister event. Contact Karen Preston if you are interested in helping out.

One final note: For those of you on Facebook, Mark Werner created a Facebook group for FLYC. Come join us by searching Facebook for 'Folsom Lake Yacht Club'. Mark makes sure announcements go out to all members of the group before meeting, races, and other events. It's just another way to get more involved with the club.

## Treasurer's Report

The Camellia Cup and Trans-Folsom appear to have been very successful this year. The latest accounting update shows a profit of about \$1050, with a few tshirts still in the graphics shop, and a check to the CG Auxiliary yet to be cut. That's about average for the events.

Financially speaking, the busiest, most interesting and expensive months of the year are behind us. Budget projections for the year indicate the club will be ahead about \$1500 by New Year's day. The average number for the last few years has been about \$1700, so we are pretty much on track.

Another letter from the Franchise Tax Board. (Teeth gritted.....) R-r-r-r-r-i-i-i-p ..... S-s-s-l-l-l-i-i-i-p..... Hmmmm..... OMG!!!! After several hours of the Commodore and I digging up data and creating documents, \$20, and several months of waiting, The Club has received a 'Certificate of Revivor' letter. To quote, "This business entity has been relieved of suspension or forfeiture and is now in good standing with the Franchise Tax Board." Now I need to figure out how to stay in their good graces. You'd think it would be obvious, but NOTHING is, when dealing with the bureaucracy. A simple example. We sent the info about the corporation issues to the Secretary of State, but get letters back from the FTB. Nothing from the SOS. Perhaps that explains why it takes almost a month from the time we were 'Revivor-ed', 4/19, until the letter was mailed, 5/11. Maybe, if there weren't two departments involved.....

Reading the FTB documents, you think you have it figured out, and then there is the ubiquitous 'if.....!' statement that changes everything. And the IRS documents are much, much, much more complicated. Who knew there were 27 organization types recognized under 501(a) as defined by 501(c) 2, 4 thru 10, 12, 13, 15, 17, 19 and 25 of the Internal Revenue Code???? Or, 'Note: For the addresses for filing Form 1024, see Form 8718.' And, oh by the way, that's where the fees for filing are found. The mailing address is buried in the fine print.

I very much enjoy the accounting and the numbers. Dealing with the legal issues suck, I'm not good at it, and it takes huge amounts of boring, mind-numbing time. And I'm never sure I'm doing things correctly. It would have helped if all the original documentation on the corporation--Articles of Incorporation, Tax-Exemption letters, and apparently pretty much everything else, hadn't been lost over the years. But, considering that it looks and reads like ancient Greek Gobbledygook to most of us, I'm not surprised.

But, WAIT!!!! What's this odd sized piece of paper, buried

at the bottom of a folder labelled 'Tax Returns--or Not' ?? (I put a fresh label on it--the old one was nearly worn off.) It's only a 'Statement by Domestic Corporation' from 1973, Christopher Longaker, Commodore, Robert V. Coyne, Treasurer. Looks like a pre-199 form---but no, we have 1971 copies of 199. It isn't clear what the purpose of the form is, but it is a tear off. Maybe the important part was the other part. And so it goes. One of the latest sheets (until today) in this folder is from the FTB, dated 9/03/99, addressed to the 'Folsom Boat Club Inc, 'FINAL NOTICE BEFORE SUSPENSION OR FORFEITURE'. And then the fight started.....

## Annual Big Brother/Big Sister Event

This popular annual event will be held on June 26, 2010 at Brown's Ravine. For those of you unfamiliar with this event, Club members volunteer to go sailing in the morning and eat at picnic BBQ lunch afterward. Who could resist this? The BB/BS organization plans outings that their Big/Little pairs can attend. For the past 8 years, Catalina 22 Fleet 4, joined by Folsom Lake Yacht Club, has organized a day of water fun for these kids. BB/BS kids are generally from single-parent homes and need a good adult role model and friend. They usually have no experience on boats, and maybe don't even get to play in a lake. This event helps expose them to new experiences while having a great time. This event has been so popular that many participants (kids and skippers alike) have come for many years in a row. The volunteer boats are rigged and ready to go by 9:30 AM, and then the skippers meet at the hilltop picnic area to pick up their kids. By 10:00 everyone should be on the water. Some boats actually sail, but mostly the kids love to gather in an area to shoot water cannons from boat to boat, and go swimming. Returning to shore around 12:30, everyone (boat skippers, too!) get a lunch of hamburgers, hot dogs, and all the usual picnic foods and drinks that kids need to have fun. The event wraps up with a group photo around 1:30. We usually have about 20 pairs needing a ride, so we need about 10 – 12 boats to sign up. ### CULT BOATS?

If you are now a C22 owner, or ever have been, you may have unwittingly been a member of a cult! A cult is described as “devoted attachment to, or extravagant admiration of a person or idea; a group of followers.” Doesn’t that just sound like Fleet 4 members? A recent article in the June 2010 issue of SAIL Magazine claims that C22 owners, and Frank Butler, the owner of Catalina Yachts are cultish about the Catalina 22. David Schmidt wrote an article about the versatile Catalina 22, and he calls it Everyman’s Sailboat. On page 78, he writes a glowing article about Mr. Butler and his 1970 dream to “build good boats that are a good value to our customers.” Mr. Schmidt credits the C22 with “two important things with the purchase: a sailboat with great value and a great community.” If that seems cultish to outsiders, then we just have to open their eyes to the possibilities presented in owning a great boat, the C22. My advice, though, is stick to the wine, avoid the cool-aid!

With the TransFolsom and Camellia Cup racing events in the past for 2010, we are now looking forward to the Regattas at Gold Country YC and the races being held at Huntington Lake. Don’t forget the upcoming All Catalina event at Clear Lake. At the time of this news article, there was no accurate counting of C22s registered at GCYC, but past events have been very successful at Scott’s Flat Reservoir. In talking with Lynn Buchanan, I got the message that GCYC was looking forward to good participation again this year. Each hosting Yacht Club has the flexibility to require varying stipulations. These are typically printed in the NOR (the Notice of Race) or the event’s Sailing Instructions. Sometimes the wearing of life vests may be required and may be included in the Sailing Instructions, or there may be a signal flag on the Committee boat that requires wearing of the PFDs. This would be Code Flag Y, which has a yellow and red diagonal stripe. This is particularly important this year, with late snow melt and cool temperatures. The water at Scott’s Flat will be cold. Be prepared.

Sail Measurement and boat certification are an important part of race readiness. C22 regional and national events may require sail measurement and certificates to be current. I read the One-design rules about measuring the sails and banding the mast and boom. I thought, How hard can it be! And then... Well, it wasn’t difficult so much as exacting. By the time I had finished my first experience with measuring and banding I had learned about what makes a sail legal for the one design racing of a Catalina 22. Several Fleet 4 members are now race ready.
